The technical and human infrastructure along with the "know-how" of strategic partners, such as testing laboratories located in China and Mexico allow products to be tested from origin, avoiding the logistical and operational costs to import samples for certification.

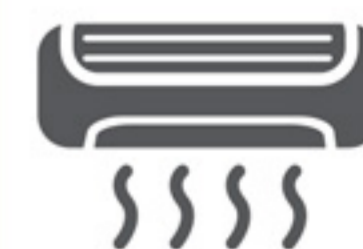

COUNTRY OF ORIGIN SHIPMENT INSPECTION

NYCE ASIA offers different types of inspection to satisfy the user needs. Such as:

- Initial inspection (first articles).
- In-line inspection (in the process).
- Final inspection (pre-shipment).
- Shipment inspection (proof of release).

The inspection process involves accurate verification using different control methods, such as the following:

- Safety requirements.
- Preservation, identification and packaging.
- Shipment quality.
- Packaging.
- Marking and labeling.

Business Information Compliance Inspection Report.

NYCE, since March, 1997, is accredited as a Compliance Inspection Unit before the entity Mexicana de Acreditación (EMA) and approved by the General Directorate of Standards of the Department of Economy, under the tracking number UVNOM005.

The Mexican Official Standards of Business Information compliance can be proved with two different documents: on one hand, the Certificate of Conformity, and on the other, the Compliance Dictum.

The services that the NYCE offers are:

- The prototype label development in compliance with the NOM (Mexican Official Standard).
- Labeling review.
- Packaging, instructions and guarantees review.
- Labeling review (subsequent to the importation).
- Compliance Dictum issue (subsequent to the importation).

Merchandise Labeling and Reconditioning.
